Pursuant to 35 I.A.C. § 845.760(b) and 40 CFR 257.102(f)(2) Illinois Power Generating Company is providing this demonstration to extend the time necessary to close the GMF Gypsum Recycle Pond at the Coffeen Power Plant because "it was not feasible to complete closure of the CCR unit within the required timeframes due to factors beyond the facility's control."

This submittal serves as an amendment to the previously submitted closure plan to indicate that the timeframe to complete closure has been revised to prior to November 2028.

Illinois Power Generating Company submitted an initial closure construction permit application for the GMF Gypsum Recycle Pond on July 28, 2022. Approximately 39 months have passed and permits required to begin closure construction have not been issued by IEPA. Illinois Part 845 and the federal CCR rule provide that the "[t]ime required or delays caused by the need to coordinate with and obtain necessary approvals and permits from" the state agency can be considered in justifying the need for an extension of the closure deadline. Based on the delay in receiving the closure permit from IEPA and the schedule of closure activities included in the closure plan, it will not be feasible to complete closure of the GMF Gypsum Recycle Pond by the date specified in the closure plan. Therefore, this demonstration justifies an extension of the timeframe for closure by two years.
