Dear Mr. Vela:

Pursuant to 40 C.F.R. § 257.102(g) as incorporated by reference in 30 TAC § 352.1221, Luminant Generation Company LLC (Luminant) is providing notice of intent to close Permanent Disposal Pond 5 (PDP-5) at the Martin Lake Steam Electric Station (MLSES). Enclosed with this notice is written certification by a qualified professional engineer that the design of the final cover system for PDP-5 meets the requirements of 40 C.F.R. § 257.102. This notice of intent to close PDP-5 was placed in the facility's operating record on February 1, 2024, and will be placed on our website at <a href="https://luminant.com/ccr">https://luminant.com/ccr</a> within the next 30 days.

Luminant ceased receipt of all waste streams in PDP-5 by January 2, 2024, when Luminant submitted a request to USEPA to withdraw the initial Part B application submitted in November 2020 and the subsequent Alternate Liner Demonstration package submitted in November 2021. On February 1, 2024, Luminant will begin taking the steps necessary to implement PDP-5's closure plan which is ultimately subject to approval from the Texas Commission on Environmental Quality (TCEQ). The written closure plan may be amended and submitted to TCEQ as required during final design activities.
