Dear Mr. LeCrone:

On January 20, 2021, Electric Energy, Inc. (EEI) submitted a notice of planned participation (NOPP) to the Illinois Environmental Protection Agency (IEPA), demonstrating that the Joppa Power Plant's Units 1-6 qualify as electric generating units that will achieve permanent cessation of coal combustion no later than December 31, 2028. Pursuant to 40 C.F.R. § 423.19(f)(3), EEI submits this annual progress report.

EEI has completed the following actions since the previous progress report submitted on January 20, 2022:

- Prepared and submitted to IEPA, on July 28, 2022, a closure construction permit application, as required under 35 IAC Part 845.
- Obtained a modified and re-issued NPDES permit authorizing discharge of ponded and subsurface free liquids associated with pond closure activities.

EEI has had no missed or delayed milestones and permanently ceased coal combustion on August 31, 2022, thus, this will be the final progress report.
